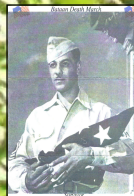

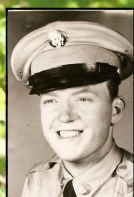

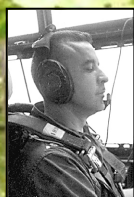

 ★ If TWC indicates dangerous storms all morning, there will be a Memorial Salute only at High School Gymnasium.

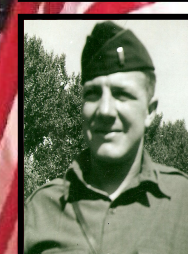

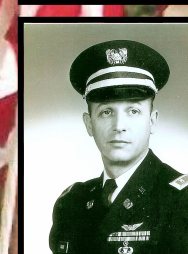
